This product was launched in 2012.

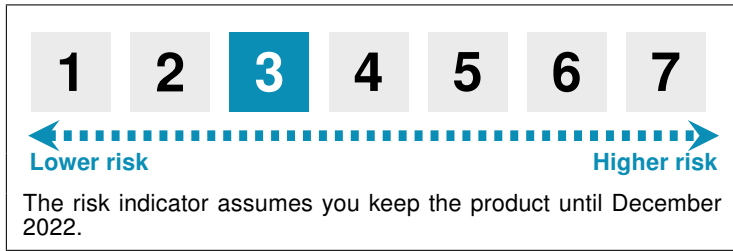
Term of product:
