What is this product?

Type:

A Luxembourg Investment Fund (Fonds Commun de Placement - Specialised Investment Fund).

Objectives:

The investment objective of CIGOGNE FUND - Convertible Arbitrage, is to realize consistently high risk-adjusted appreciation in the value of its assets. The sub-fund will seek to achieve its investment objective by primarily using convertible arbitrage strategies on US, European and Japanese listed stocks and bonds.

Convertible arbitrage is an investment strategy that is designed to profit from identifying mispricings or expected return differentials that exist between a convertible security and its underlying security.

The sub-fund may invest in equity securities, warrants, bonds and other fixed-income securities. For the purpose of efficient portfolio management and for currency hedging in the context of the management of its assets and liabilities, the sub-fund may engage, with

collateral if necessary, in options, futures, swaps, securities lending or borrowing and other derivative instruments or techniques, traded on an exchange or over-the-counter.

This sub-fund was launched in 2005 and this product in 2005.

The currency of the product is expressed in EUR.

This product is a capitalisation product meaning that income and capital gains are reinvested.

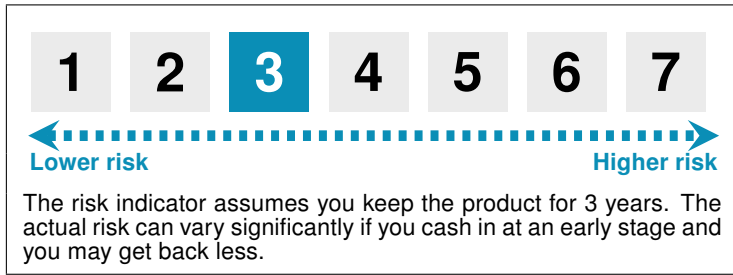

What are the costs?

Costs over time

How long should I hold it and can I take money out early?

Recommended holding period: 3 years
