## What is this product?

#### Type:

Investment Company with Variable Share Capital - Specialised Investments Funds (SICAV-SIF)

#### Objectives:

The investment objective of CIGOGNE CLO ARBITRAGE - EUROPE, is to realize consistently high risk adjusted appreciation in the value of its assets.

The sub-fund will seek to achieve its investment objective by primarily using arbitrage strategies on all types of debt securities and debt instruments issued by public and/or private issuers worldwide, including, without limitation, fixed rate bonds, variable rate bonds, inflation linked bonds, collateralised debt obligations, collateralised loan obligations, mortgage backed securities, asset backed securities. The debt securities and debt instruments the sub-fund will have the possibility to invest in, are not subject to any restrictions regarding the level of rating from one of the recognized rating agencies. In addition, the debt securities

and debt instruments the sub-fund will have the possibility to invest in, may have no rating at all.

This sub-fund was launched in 2010 and this product in 2015.

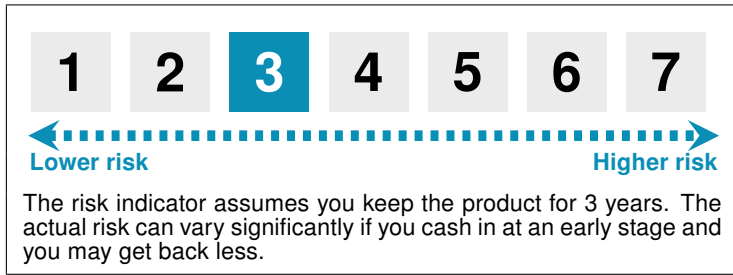
